

**Village of Dieterich
Village Board Minutes
June 18, 2018**

The Dieterich Village Board met in regular session on Monday, June 18, 2018 at 6:30 PM at Village Hall.

The meeting was called to order by President Brad Hardiek and the Pledge of Allegiance was recited.

The following Trustees were present: Carrie Galbraith; Steve Kibler; Jeff White; Jennie Vail; Mike Meyer and Mike French. With six Trustees present, a quorum was declared to be present. Also at the meeting were: Clerk Brittny Gipson; Effingham County Sheriff David Mahon; Sean Pankau; Sean McQueen; Luke Bierman; Brian Emmerich; and Derek Stumeier.

Effingham County Sheriff David Mahon was a guest at the meeting and was asked to give his opinion on passing an ordinance to allow for the legal operation of golf carts in the Village limits. Sheriff Mahon said he spoke to the police chiefs in Altamont and Teutopolis and they have had no issues with allowing golf carts in their communities. If residents are operating golf carts on the roadways in Dieterich, it is currently the Effingham County Sheriff Deputy's discretion to write a ticket or give a warning. Sheriff Mahon talked through the rules that would need to be set and the inspections that would be needed, if Dieterich chose to pass an ordinance to legalize golf carts. The Sheriff suggested that legalizing golf carts would give the Village better control, but ultimately it was a Village Board decision whether to legalize them or not.

Dieterich residents Luke Bierman, Brian Emmerich, Sean Pankau, Sean McQueen, and Derek Stumeier were all present to urge the Village Board to consider passing an ordinance to allow golf carts on Village streets. Each resident gave reasons why they thought an ordinance should be passed.

A motion was made by Trustee S. Kibler; seconded by Trustee J. Vail to approve the omnibus agenda; approve minutes of the June 4, 2018 regular meeting. Roll call was 6 yes and 0 no.

During the Water/Sewer/Streets portion of the meeting, it was agreed the fire hydrant at the end of East Section Street should be moved in order for the sidewalk to be installed as shown per the plans.

A motion was made by Trustee M. Meyer; seconded by Trustee J. White to approve Ordinance 900-18: Making Appropriation for the Corporate Purposes of the Village of Dieterich, Effingham County, Illinois, for the Fiscal Year Commencing May 1, 2018 and Ending April 30, 2019. Roll call was 6 yes and 0 no.

A motion was made by Trustee M. French; seconded by Trustee C. Galbraith to approve Ordinance 901-18: Village of Dieterich, Effingham County, Illinois

Ascertaining the Prevailing Rate of Wages for Laborers, Mechanics, and Other Workers Employed in Public Works of Said Village. Roll call was 6 yes and 0 no.

A motion was made by Trustee J. Vail; seconded by Trustee M. French to approve Ordinance 902-18: Amending Chapter 3 of Title 8 of the Village Code of the Village of Dieterich, Illinois. Roll call was 6 yes and 0 no.

President Hardiek reported there was no new information regarding the Closed Session agenda item of discussion of a land purchase, so no Closed Session was needed.

At 7:45 PM a motion was made by Trustee S. Kibler; seconded by Trustee C. Galbraith to adjourn the meeting. Roll call was 6 yes and 0 no.
